4. Achievements:

4.1. Evidence-based advice to feed into policy reform and improved decision-making

- Two case studies produced and a further two researched:
 - o "A regional policy that drove change" June 2013
 - o "Africa Unites and Illegal Fishing Industry Pays" July 2013
 - Research done for "The FISH-i Africa Task Force"
 - Research done for "Illegally fished, illegally transhipped and legally consumed"

- SIF attended the 1st Advisory Meeting for the African Fisheries Reform Mechanism held on the 25th – 26th April 2013 in Maputo, Mozambique.
- SIF representatives attended the Writers'-Shop on the development of Policy Briefs in support of the Pan-African Fisheries Policy Framework and Reform Strategy in July 2013 in Lusaka Zambia. While there, SIF wrote two policy briefs for Conference of African Ministers of Fisheries and Aquaculture (CAMFA).



4.2. Coordinate an African Voice to influence international fishery policy processes

- Strengthened the network of African fisheries ministers and decision makers through the work of SIF and FISH-I, particularly in Liberia, Mozambique, Seychelles and Sierra Leone.
 - Supported the Republic of Seychelles' Minister for Natural Resources, the Honourable Peter Sinon, as a speaker at an event designed to encourage the European Union (EU) Member States to take stronger action against illegal fishing.

4.3. Facilitate communications and education to create awareness and advocacy

- SIF continuously updated the website with news and information in addition they performed two website technical updates, which included the development of a web-based e- newsletter function.
- SIF produced and disseminated two newsletters, one in March and one in December 2013.
 - SIF further developed its social media presence, gaining over 2 000 'likes' on Facebook and over 500 'followers' on Twitter.
 - The support of SIF facilitated FISH-i's production of:
 - o An informational flyer;
 - A FISH-i map;
 - o A calendar;

- o and a FISH-i movie.
- The Republic of Seychelles' Minister for Natural Resources, the Honourable Peter Sinon, referenced SIF and FISH-i at a large event in Europe, gaining both exposure and press coverage.

4.4. Build, develop and assist with cooperation tools, mechanisms and processes

- SIF played a key role in the FISH-i initiative by:
 - Facilitating the network and task force;
 - Coordinating stakeholder meetings;
 - o Researching case studies; and
 - Providing technical support.
- SIF collaborated with, and provided support to, Interpol's Project Scale, which is focused on illegal, unreported and unregulated (IUU) fishing cases.
- SIF and members of the SIF network attended Interpol meetings on fisheries crime in:
 - o Cape town May 2013
 - o Nairobi November 2013

4.5. Provide capacity building

- SIF facilitated a workshop on Combating IUU Fishing held in Djibouti in October 2013.
- SIF developed plans for capacity building in Ghana for local sub-region.

4.6. Facilitate improved information and intelligence exchange

- The SIF website continued to be the go-to site for news relating to IUU fishing in Africa and globally. Importantly, the site contains:
 - o A combined IUU fishing vessel list; and
 - SIF-researched, cutting-edge front page stories, which aim to highlight important issues in the fight against IUU fishing.
- SIF not only convened but played an active participation in FISH-i Africa, particularly Basecamp, contributing to the exchange of information between technical experts and fisheries professionals related to IUU incidents and cases.



4.7. Grow and support a network of professionals, experts and champions

- SIF fully supported the FISH-i initiative and its work to expand the network of fisheries
 professionals working to combat IUU fishing. SIF participates in FISH-i meetings, Basecamp and
 provides input to programmatic planning;
- The SIF newsletter reached over 1000 subscribers; and
- SIF entered the International MCS Network's Stop IUU Fishing Award contest in 2013 in order to bolster relationships with other MCS organizations and practitioners.

4.8. Development of SIF's organizational model

- SIF became a registered not-for-profit Society under the laws of Botswana April 2013
- SIF established an independent bank account with First National Bank Botswana (FNB) May
 2013
- SIF developed a funding flyer September 2013
- SIF established a Foreign Currency Account with FNB October 2013
